Skewed pricing dulls govt housing push
Anarock chairman Anuj Puri

said there is a shortage of 19 million units in urban India, and of this almost 96% pertains to the economically weaker section (EWS) and lower income group (LIG) categories, which is also the target of the government's affordable housing push.

Puri explained that unlike earlier, developers are quite keen on affordable housing, despite the lower profit margins as compared to the luxury or ultra-luxury segments. However, they are facing problems like high land prices in the municipal limits of major cities (where urban affordable housing is most needed), which makes it unfeasible for developers to launch such projects. Another major issue impacting this market is the lack of basic infrastructure in peripheral areas, which reduces buyer interest and impacts supply.

Despite high demand for affordable houses across Delhi NCR, Mumbai and Bangalore, launch of new affordable housingunits witnessed a steep 20% drop quarter-on-quarter(Q-oQ) in Q2 2019CY. New supply fell to 25,580 units compared to 32,060 units in Q1 2019.


